ACKNOWLEDGEMENT OF COVID-19 RESTRICTIONS FOR BASKETBALL/VOLLEYBALL COURTS & BATTING CAGE RESERVATONS

The following rules must be read to the renter / user at the time of reservation, and a verbal consent is required. These rules will also be attached with each receipt for all basketball/volleyball court and batting cage rentals; and all coaches, players, and spectators should be made aware of these rules.

- 1. Only 10 players and 1 coach allowed on court at any time. One additional assistant coach may be added if 10 players are divided into 2 groups of 5.
- 2. The maximum number of people permitted per court area is 32, which includes: 10 players, 2 coaches, and 2 spectators per player (20) per court for volleyball or basketball. Only essential personnel and child supervisor should attend practice or rental function.
- 3. Bleachers in gyms are closed until further notice.
- 4. Coaches, spectators, and youth players should bring their own chairs made for indoor use with rubber or felt tips to ensure they do not cause damage to flooring
- 5. Coaches, players, and spectators will have assigned areas in which to sit.
- 6. Coaches, players, and spectators acknowledge that any equipment shared by their players must be cleaned after each use and that coaches / renting parties are responsible for providing their own cleaning/sanitizing products. WCPRD will **not** provide any type of sports equipment (i.e. basketballs, volleyballs) for shared use at this time.
- 7. All parties must practice social distancing staying 6 feet apart.
- 8. Team meetings, huddles, and activity meetings (before or after) are not permitted in indoor court areas. Teams must go into the open hallway space or proceed to parking lot or open green space to meet after their rental and still must adhere to 6-foot social distancing rules.
- 9. Tobacco or vaping products, sunflower seeds, gum, or candy is not permitted in indoor facilities areas.
- 10. Coaches should provide hand sanitizer to participants and should also encourage frequent hand washing.
- 11. The wearing of masks inside all WCPRD facilities by all spectators, coaches, and youth players is mandatory, except when involved in strenuous athletic play. Temperature checks and covid questionnaires will be conducted for each person entering WCPRD facilities.
- 12. WCPRD has the right to create rental schedules and breaks in schedules to accommodate time for WCPRD staff to disinfect and sanitize facilities in between rentals and activities.
- 13. Handshakes, high fives, hugs, and other physical contact should not occur between patrons and/or players to help reduce the spread of the virus.
- 14. All other park rules and polices remain in place including but not limited to WCPRD Severe Weather Policy, Code of Ethics, Animal Policy, Smoking Policy, Gym Rules and Regulations, etc. Patrons are asked to follow all posted rules.
- 15. WCPRD reserves the right to cancel, postpone, alter, change, modify, or reschedule any and all events on WCPRD / Warren County Property for any reason, including but not limited to Covid-19 related issues, public health and safety matters, unforeseen circumstances, operational matters, facility scheduling matters, severe weather matter, scheduling issues / conflicts, etc.
- 16. Users should understand they will be read these rules when they reserve a court or batting cage, and they must give verbal consent at that time. Also, they will be emailed a copy of this acknowledgment with their rental receipt. By giving verbal consent at time of reservation, users understand that failure to comply with the above rules will result in them being asked to leave the facility and not being permitted to rent in the future.

This document may be changed by the WCPRD Director as policies, procedures, and Covid-19 response measures are updated. All items are subject to change, modification, deletion, or addition of information.

Any and all individuals, including minors, understand that participation in any event, rentals, activity, function, program on WCPRD Property is at his/her own risk and that WCPRD, Warren County Fiscal Court, all of its partnered organizations, volunteers, and representatives will not be held legally liable or responsible for any injuries, accidents, Covid-19 related exposures, or claims while conducting these types of programs.
